- Discussed Petition from landowners in new Trail Creek/Harris Creek subdivision to join PFPD and become part of the Taxing District. Proper Public Notice of Intent will be required before commission vote in July. Public input would be allowed in the July meeting prior to the vote.
- Discussion was deferred on additional Budget Item transfer needs.
- Discussed the need for two gas/diesel fuel tanks for supplying fuel for our vehicles.
